Budget has passed.


Celtic Society Demo—George

Will be writing letter to the coordinators to ask if we can demo there. The joust is the 28th of August. We can do an hour or so of foot combat in the morning




before the joust, in addition to a static display.

A financial committee meeting was held on March 30th, 2010, and the budget for Challenge of the Heart 2010 was discussed and approved.


