## Exchequer's Report

Absent, but posted this on e-list:

I won't be able to attend the 02/05/13 business meeting due to work-related travel. So here is my Officer's Report for January and February (since there was no meeting in January):

1. Registry balance was \$5,893.01 as of 01/30/13.
  - That is down about \$650.00 from the end of 2011.
  - \$600.00 of that was a transfer to Kingdom Fund (settlement of suit).
  - We also spent about \$550 on repair/replacement of Baronial equipment (tabards, hangings, kitchen totes, etc).

- Due to good fiscal policy and the generosity of the membership, we made back most of that repair/replacement expenditure.
  - Our events are consistently well-managed fiscally and usually turn a small profit.
  - **Thanks and praise are due to all Baronial members for good stewardship of Baronial funds in 2012.**
2. Fourth Quarter 2012 and Domesday 2012 reports complete, signed, and submitted and have been received by Regional. Many thanks to Matt Keck for assistance
  3. Baronial Financial Policy revised at Financial Committee meeting 01/27/13
    - Revised Policy posted to Seadogs list and most recent *Clyffe Notes*
    - Brings Policy into line with most recent Corporate, Kingdom and Regional policy
    - Most significant change is addition of an Emergency Committee and protocol for same.
    - Next steps are as follows:
      - Revised Policy to be voted on by the Barony (Feb. or March meeting)
      - If Barony approves, send Policy to Kingdom Exchequer for review
      - If Kingdom approves, Policy takes effect
      - Policy published in newsletter for two months running
  4. New Baronial checks have been ordered but not received:
    - Duplicate checks per Kingdom policy
    - My address on them instead of Matt's
    - Office expense—under \$25.00.
  5. Next on the agenda—discuss Baronial Pavilion replacement costs
    - Purchase price of current pavilion: \$1,066.70 in 2002
    - **Upper boundary** of cost for replacement: Panther Primitives 16x20 Marquee pavilion:
      - Fabric portion: \$1,900 - \$1,435 depending on fabric weight, water- and flameproofing
      - Poles, ropes and stakes package: \$764

    - Recommend that a **conceptual** reserve be established: half extant funds and half new funds to be raised this year (additions to general revenue—no dedicated fund).




